We have selected **Harrah's Casino Hotel** located at 219 North Center Street, Reno, NV 89501. Phone number is 775-786-3232. The room rate is \$84.00 plus a \$14.00 resort fee, plus taxes per day.

The hotel has set up an online reservation link to make reservations. The rooms at the hotel are set up for double occupancy; if you add additional people to your room the hotel will charge you \$10.00 per day during your stay. Maximum number of people in a room is 4.

The hotel has a shuttle from the airport to the hotel and from the hotel to the airport.

We have been informed that the hotel is located about 5 miles from the convention center. There is no shuttle from the hotel to the convention center, but cabs are available at a cost of about \$10.00 each way. As usual, the hotel will have a limited number of rooms available for those cooties that want to stay in the cootie hotel and attend the VFW convention. Information on wheelchair or electric cart rentals and will be posted as received.

With the hotel being in downtown Reno, there are numerous locations to eat, within a reasonable walking distance; plus, several dining locations within the casino. The hotel offers a senior buffet; **buy one at regular price and get one free.**
