- 8. <u>Pup Tent Scratches:</u> In accordance with Supreme By-Laws, Article II, Section 213, all Pup Tents shall hold at least one scratch per month.
- 9. <u>Hospital Reports:</u> Monthly Hospital Reports are due by the 7th of each month and should be sent directly to the Grand Hospital Chairman Robert "Check" Adamczyk. Reports should be emailed to mrcheck@gmail.com.
- 10. <u>Blood Reports:</u> Blood Reports should be submitted to http://vampire.puptent1.org/ in order for the computer to recognize your effort. Questions or pleas for assistance may be directed to the Supreme Vampire via the above page.
- 11. <u>Pup Tent Inspections:</u> Pup Tent Inspections will begin in August. The inspector will give advance notice of their visit and it is important that you be prepared with the updated books and records of the HC and CCDB. In addition, you should have on hand proof of your CCDB bond and the latest Quarterly Report of Audit. Attendance of the SS, HC, and CCDB is paramount to a quality, worthwhile visitation.
